Liability Release Form

This Agreement is effective between, The Border City Classic Tournament Director, Staff, all of the Sponsors, and the Participant below.

The Participant of Border City Classic Tournament Director, Staff, all of the Sponsors agrees to the following provisions:

1. The Participant agrees to faithfully and diligently follow the instructions and advice and cooperate at all times with The Border City Classic Tournament Director, and Staff.
2. The Participant agrees to fully and completely release The Border City Classic Tournament Director, and Staff from any and all liability arising out of any relationship with The Border City Classic Tournament Director, and Staff.
3. The Participant expressly agrees that The Border City Classic Tournament Director, and Staff, shall not be liable for any damages arising from personal injuries or otherwise sustained by the Participant or any guest in, on , or about any of the BCC tournament location premises. By the execution of this Agreement the Participant accepts full responsibility for any such injuries or damages which may occur to the Participant or guest in the Participant's involvement with The Border City Classic Tournament Director, and Staff, and further agrees that the Participant shall not be liable for any loss, damage or theft of any personal property.
4. The Participant assumes full responsibility for any injuries, damages or losses which may occur to Participant or guest in, on or about the premises of Tournament Locations, and does hereby fully and forever release and discharge The Border City Classic Tournament Director, and Staff.
5. The Participant agrees to defend, indemnify, and hold The Border City Classic Tournament Director, and Staff harmless for any and all damages, charges, loss, and expenses (including reasonable attorney fees and costs) for any claim arising out of any circumstance with the Participant's involvement with The Border City Classic Tournament Director, and Staff.
6. The Participant agrees that this release is clear and unambiguous and fairly and knowingly made by the Participant.
7. The Participant agrees that he or she is of sound mind, at least 18 years of age, and that The Border City Classic Tournament Director, and Staff has not misrepresented the nature of this Agreement.
8. The Participant agrees that this Agreement with The Border City Classic Tournament Director, and Staff regarding the release, waiver, indemnification and hold harmless of The Border City Classic Tournament Director, and Staff' liability shall not be modified without the express written consent of both parties.
9. The Participant agrees that if any provision of this Agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions will continue to be valid and enforceable. If a court finds that any provision of this Agreement is invalid or unenforceable but that by limiting such provision it would become valid and enforceable, then such provision will be deemed to be written, construed, and enforced as so limited.
10. This Agreement shall be governed by and construed in accordance with the laws of the State of Michigan, USA, and Province of Ontario, Canada.
11. The Participant will be responsible for attaining a legal PFD, agrees to wear such PFD for the duration of the event while on the water.
12. All Participants are responsible to know all the rules and regulations of the event and including any interpretations or changes of the rules (eg. Launch locations, changes of boundaries) that will be announced on Thursday June 21st 7pm on the BCC Facebook Page. If you are unable to view the FB Live Meeting, you can view it anytime afterwards as it will be posted.

All participants consent that The Border City Classic Tournament Director, and Staff may use, without payment, restriction or permission any photographs, videos and other information taken by The Border City Classic Tournament Director, and/or Staff, where the participant may appear or be named for any purpose including, but not limited to, print and electronic distribution with a privacy policy of never sharing information with any third parties or other partners.
